# INEQE Audit Update / Training delivery for the remainder of 2024 and January

Ahead of March's Safeguarding Audit of Bath and Wells, the auditors INEQE, have now opened the survey that we are asking people across the diocese, including yourselves, to engage with. We will be sending details of the survey directly to some of those we hope will engage with it, such as survivors, and promoting it widely so we can have get as much information to support us as we seek to continued to improve safeguarding in all our settings.

As well as asking for your views using the survey, before the audit there will be focus groups held with PSOs which I hope many of you will take part in. Details of these will be shared in due course.

Please also bear in mind that the audit is a lengthy and resource-heavy process that needs to be completed by the middle of January, so please bear with the team during this period as response times may be affected. We will also be reducing the amount of training delivered in December and January in order to divert some of our resources to this work.

# Safeguarding Dashboards

You may have recently seen Bishop Michael's bulletin which made the announcement that Dashboards were now diocesan policy and must be completed by all parishes. Those parishes not receiving dashboards have received an email from the team asking for assurance that appropriate safeguarding measures are in place. We now only have 17 parishes not signed up to using them. The team will continue to do all they can to promote dashboard use and support your use of them.

## Changes to how you contact the safeguarding team

From January 2025 we will be moving towards having a central phone line for the safeguarding team rather than individual staff numbers. This is to enable us to prioritise enquiries and ensure that we can get everything done in a timely manner. We will be monitoring the new system when it is in place to determine if it helps people get in touch and receive a timely response, and welcome your feedback.

As a very small department covering 466 parishes and a Cathedral, we have at times struggled to keep up with the growing demand on us – due to he high levels of training, engagement and proactive work by all our church communities.

You can help us help you by noting the following:

- 2. DBS eligibility query or DBS platform technical query: Call 31:8, who manage the system for Bath and Wells on 0303 003 1111.
- 3. Training queries: Email: training.safeguarding@bathwells.anglican.org
- 4. Dashboard queries or general / non urgent enquiries: Email:<u>safe.guarding@bathwells.anglican.org.</u> Please also use this mailbox to request things such as support with a new PSO or if you need some one-to-one support so that our safeguarding coordinator can book an appointment in.
- 5. Safeguarding referrals or concerns: ideally these should be made online via the<u>Reporting concerns or abuse web page</u>. This allows the team to assess the concern and respond appropriately. It also means it can be actioned by either Jo or Ben. They can also take referrals by phone and will always respond to a referral within 24 hours.
- 6. Out of hours emergency helpline 0303 003 1111.

## **PSO celebration events**

In order to celebrate the contribution made by Parish Safeguarding Officers, a number of events are planned by Bishop Michael in May and June next year at the Bishop's Palace. Invitations will be sent in the new year and I hope to see as many of you there as possible so I can thank you for all you do, in person.

# Christmas office closure dates

The Safeguarding office will be closed between 23 December 2024 and 3 January 2025. During this period there will be daytime and out of hours cover for safeguarding by our out of hours provider, 31:8 on 0303 003 1111.

Should any significant, urgent issues arise these be reported to your archdeacon who can escalate the concern to one of the Safeguarding team if required.

# Safer recruitment and support for publicly recognised Church roles Safer recruitment and support for publicly recognised Church roles

As a diocese we are committed to supporting all those in ministry. Many people exercise an important ministry in support of pastoral care or in leading worship. There are a number of resources available to assist in the equipping of Lay Pastoral Assistants and Lay Worship Assistants. It is important that those called into these roles are safely recruited and all have undertaken the appropriate safeguarding checks and training. We track this via a registration process, renewable every three years.

DBS enquiries - <u>email dbs.safeguarding@bathwells.anglican.org</u> or if it relates to eligibility contact 31:8 directly on 0303 003111 as they manage DBS for us.

Safeguarding referrals - please use the <u>reporting form on the diocesan</u> <u>website</u>. This allows the team to review and respond accordingly. Alternatively contact Ben or Jo by telephone. All referrals will be responded to within 24 hours.

Out of hours emergency helpline - 0303 003 1111

For non-referral queries, the quickest way of reaching Ben and Jo is via email - this allows them to prioritise the most pressing enquiries according to need.
