## Dear Deanery Synod members

It has been an honour to serve as a representative of Bath and Wells on General Synod for the past eight years and I hope you will give me your support to continue.

General Synod does work which is important both for the Church and beyond, including on safeguarding, where there is still more to be done to make sure that survivors' voices are heard and that the abuses of the past can never happen again.

Synod has oversight of the Church's finances and financial priorities, decides on Church structures and organisation, and has the responsibility of voting on new forms of liturgy.

And then there is Living in Love and Faith: study materials, videos and discussion guides about human sexuality. There will be opportunities to take part locally before a General Synod debate in the next two or three years.

Whilst it is important to reach out to more people through new forms of worship in new places and through chaplaincy in schools, colleges, hospitals and workplaces and wherever people gather, and this work should be acknowledged and celebrated, the parish must be affirmed as the outward and visible sign of the unique mission of the Church of England: *"here for all the people of England."* 

### Since I've been on Synod:

I have spoken in favour of the consecration of women bishops and the banning of "conversion therapy" for gay people. Questions at Synod can be a useful way of drawing attention to an issue and I have asked Questions on topics including support for clergy spouses after marriage breakup.

I was also one of the Bath and Wells representatives who tabled a record number of Questions about the proposed sale of the Bishops' Palace – which, as we all know, was eventually prevented.

I have visited, either in person or by Zoom, almost half the deanery synods in the diocese to talk about General Synod and, if I am re-elected, would welcome invitations to come to other deanery synods.

I also arranged a visit to Synod in London by a group from Shepton Mallet Deanery and would like to encourage more groups and individuals from Bath and Wells to visit in future to see how Synod works.
